# A) FIRE CHIEF JEFF BROWN

# Monthly Briefing:

- Call/Activity summary July
- We need to have a referendum on spending some money out of the Fire Truck Reserve Fund. It is already on the agenda for tonight's Village Board Meeting.
- Hose testing completed
- 4617 pm and inspection no issues
- Extinguisher hydro and inspection done

- Alarm systems testing completed for firehouse
- Thank you again to the Fire Company for allowing the Fire Department to have a three-story training maze built in the large storage building (Morton Building). It is almost completed. The company has asked if we could put up a structure to house their lawnmower and snowblower and to put in writing that the antique fire truck will always stay inside the fire house. If we can do that, the fire department could use the rest of the Morton Building for training also. Dave Merritt may donate his Amish shed (12' x 20') and have it moved to the fire company area. We would need a concrete slab to put the shed on. Perhaps the Village DPW could build that. This would allow more uses for the training building and save us future training costs (from driving to other sites).
- Getting drivers cleared this month
- Training is going well
- Chief Brown is meeting with the Clifton Fire Chief next week to discuss consolidating our fire
  police. Clifton has 3 active fire police and we have 1. We will work on an agreement for
  mutual coverage. Churchville Insurance will also be contacted to see what ramifications a
  consolidation would have on our insurance.
- The Hurst tool should be in pretty soon. The Deus System should be in next week. Due to our last round of hose testing, it appears that we will need more 1.75" hose. Chief Brown asked to spend no more than \$2,000 on 400' of hose. He would like to utilize the Fire Equipment Reserve Fund and asked that a public hearing be set. That can be done at tonight's Village Board Meeting.

<u>Upcoming Events:</u> Festival standby and 2 FF starting FF1 in September on Monday and Wednesday.

#### B) EMS CHIEF MATT JARRETT

## **Rescue Squad Operations:**

Membership update:
o Request to add Steven Wagner to EMS roster. He is a firefighter with Village FD currently;
□ NYS released a major update to EMS protocols. We are working on putting together a plan to roll out the
DOH mandated training. Training consists of 2 hour long video, quiz and skills verification;
□ No updates on radio project;
□ Notes from EMS Cooperative are attached. The project is on schedule and is progressing. I will be scheduling a meeting with Supervisor Dobson to provide her with an update on the project;
$\Box$ I am working on updating the financial documents so the 2016 budget figures can be provided to the Town for budgeting.
☐ Prepared for festival operations this coming weekend. We will have an ambulance staffed at the event

# C) <u>EXECUTIVE DEPUTY CHIEF OF COMPLIANCE AND SAFETY</u> JAY COATES

- Deputy Chief Coates asked if the Board had Attorney Skivington's revised resolution regarding volunteer fire fighters lending assistance at incidents when they are passing by in other districts. It should be discussed in the regular Village Board Meeting.
- County radio project We have been asked to update our radio inventory. There are three versions out there currently. The County has chosen to use the Chief's inventory list, which Deputy Chief Coates feels is the least accurate. This is different than the

inventory we sent in with the signed agreement. There is a Fire District Officers' Meeting on Thursday and the status of what they are doing in this regard will be discussed.

#### D) PRESIDENT FIRE COMPANY – FRANK WUNDER

- The new facings are on the sign.
- Our old exercise unit is on Craig's List. We have had no responses yet.
- The new exercise equipment has been ordered. Delivery is on hold until the old equipment is removed.
- The title on the old fire prevention truck has been requested. Once that is received, the vehicle will be placed on Craig's List to try and sell it.
- On September 3<sup>rd</sup>, we will be hosting the quarterly Fire Police Meeting. We expect about 50-60 people to attend.
- Our explorers will be working with Salvatore's Pizza to sell pizza and cold drinks at the festival as a fundraiser. Our fund drive is underway with a goal of \$17,000.
